



STORM WATER INSPECTOR
(FULL TIME, SALARY, NON-EXEMPT)
Salary Range \$37,000 – \$55,000

The Butler County Engineer's Office (BCEO), Butler County, Ohio, is seeking applicants for a **Storm Water Inspector**. The Storm Water Inspector will work under the general direction and supervision of the Development Services / Storm Water Manager. The Storm Water Inspector will be required to investigate, evaluate facts and data, enforce and maintain compliance of Butler County's Storm Water Management Plan as part of the State of Ohio's National Pollutant Discharge Elimination System (NPDES) Phase II permit program. Work consists of on-site field inspections to determine compliance with the District's Storm Water Management Plan.

The successful candidate must have an associate's degree or any such combination of education, experience, and training as may be acceptable to the hiring authority. The Storm Water Inspector must have a valid Ohio Class B Commercial Driver's License with airbrake endorsement and fewer than 6 points. The successful candidate must either have or attain this CDL within 120 days of employment. The Storm Water Inspector is required to be knowledgeable in the principles and practice of erosion and sediment controls, possess the skills to assess all conditions at the construction site that could impact storm water quality, and assess the effectiveness of any sediment and erosion control measures selected to control the quality of storm water discharges from the construction activity.

The Storm Water Inspector is required to be knowledgeable with the planning, review, installation, maintenance, inspection, and reporting of Erosion and Sediment Control practices.

The successful candidate must have knowledge in planning, reviewing, and modifying Storm Water Pollution Prevention Plans (SWPPP) associated with Ohio's Environmental Protection Agency requirements.

The Storm Water Inspector must have an understanding of general drainage, runoff control, and post-construction control practices.

The Storm Water Inspector must be able to lift manhole lids, storm sewer grates, and negotiate various terrains through construction sites, creeks, streams, rivers, and storm water features for field reviews, inspections and outfall monitoring. Employee must be able to wear safety equipment as required by OSHA, BCEO, and District safety policy.

The Storm Water Inspector must perform these functions with or without reasonable accommodation:

- Communicate well and work well with others and cooperate with residents of Butler County, vendors, customers, and employees of Butler County.
- Review SWPPP and Lot Erosion Sediment Control plan, issue permit, perform compliance inspections, and enter necessary data into county permit database.

- Advise developers of erosion control regulations and when necessary coordinate enforcement action with Storm Water Coordinator.
- Perform post-construction site inspections and verify compliance with approved development plans.
- Inspect and coordinate right-of-way, driveway and utility permit standards. This includes entering permit application entry and inspection entry into county permit database.
- Locate, document, and perform dry-weather screening of municipal separate storm sewer system (MS4) outfalls with aid of a GPS enabled tablet.
- Assist in responding to homeowner's drainage concerns, erosion of property, streambank stabilization, pond maintenance and other natural resource management related issues.
- Provide annual report to Storm Water Coordinator outlining the year's events, number of inspections, number of enforcement actions, and number of sites out of compliance.
- In addition to the regular duties, the Storm Water Inspector must be available for snow and Ice control. This requires operating a dump truck/snow plow and removing snow and spreading chemicals and materials on county roads. Must be available to perform this function during shift intervals, all hours of the day, seven days a week.

The successful candidate must perform other functions as required:

- Train new employees and review the work of interns and temporary employees.
- Perform other such duties and functions as are necessary or incidental to the proper performance of this position.

The following skills and knowledge are needed to perform the expected duties:

- Knowledge of NPDES program, regulations, goals and objectives of the Storm Water District.
- Knowledge of personal computer and/or tablet including database software, word processing, spreadsheets, and email.
- Understand and read blueprint drawings and/or electronic PDF drawings for grading, erosion control, storm sewer, sanitary and water systems.
- Working knowledge of construction practices, State of Ohio standards and specifications, ODNR Rainwater Land Development Manual, Ohio EPA NPDES Phase II Program, Ohio EPA NPDES Construction General Permit, construction inspection techniques and soils classification.
- Ability to read and interpret plans and specifications; ability to establish and maintain effective working relationships with employees, contractors, other departments and the public; ability to follow written and oral instructions; and, ability to communicate effectively, both verbally and in writing.

Unusual Working Conditions:

- Work is performed outside with exposure to adverse weather conditions, on construction sites with exposure to electrical, mechanical and chemical hazards and other unfavorable health and safety factors.
- Some work may be performed in a modern office where no unusual physical effort is required or no unusual physical hazard exposure.

The employee in this position will work from the Butler County Engineer's Office. Normal hours of work are 7:30 a.m. to 4:00 p.m. Monday through Friday.

In addition to the salary mentioned above the position includes an excellent benefits package.
